#### **Draft Minutes**

#### A. Items Opening Meeting

- 1. Call to Order Mayor Justin Hamilton called the meeting to order at 6:30 PM.
- 2. Pledge Mayor Justin Hamilton led the Pledge of Allegiance.
- Roll Call Village Secretary called roll: Present were: Mayor Justin Hamilton, Mayor ProTem Scott Staeb, Councilmember Bobby Amidon, Councilmember Jeff Schroeder, Councilmember Kevin Davis. A quorum was present.

Village attorney, Caroline Kelley Hyde Kelley LLP, in attendance.

Councilmember Daniel Mershon arrived at 6:32 P.M.

#### B. Mayor Report

Mayor Hamilton spoke about activities of the Council over the last month. Bid for Village 2025 Road Maintenance Project was awarded to Alpha Paving, \$200,000 from fiscal year 2024 funds have been designated to the TexPool Village Road Fund, reminder and enforcement efforts for compliance with Firewise principles to pick back up in January.

#### C. Public Comments

Resident invitation to visit Christmas Village display in the Venture Room. This is an incredible display courtesy of the Villemarette family.

D. Travis County Sheriff's Report – Deputy McCaughey spoke to county wide uptick in vehicle theft (tis the season!), keep vehicles locked. Speeding complaints on Venture Drive, Deputy McCaughey asked that the speed data sign be relocated for reporting.

#### Emergency Services and Code Enforcement Report - no report for this meeting.

#### Animal Control Report

November Animal Control activity – Tony Reynolds, animal control officer, provided November Summary animal control report.

- 6 Deceased Animal Response/Removal-4 deer samples submitted for testing
- 5 At Risk Animal Response-1 sick racoon suspected rabies/distemper submitted for testing
- 3 Nuisance Animal Response/Consultation
- 5 Dog at Large/General Dog Calls
- 6 Complaints (unreasonable noise/aggressive dog/other)

There has been an increase in vehicle/deer hits. Please slow down and feed deer (if you must) away from the roadways. Animal Control inquiry with Texas Parks and Wildlife regarding process to possibly get an estimate of Point Venture deer population count. Undetermined deer deaths do not pose a risk to the community.

#### E. Items to Consider

1. Approval of Minutes November 20, 2024, Regular Council Meeting.

Councilmember Kevin Davis made a motion to approve minutes of November 20, 2024, as presented. Mayor ProTem seconded the motion. Councilmembers vote in agreement. Motion carries.

2. Discussion of options for addressing parking in Village roadways and right of ways. December 18, 2024

Council discussed options to consider for enforcement of parking in Village roadways and right of ways. Parking violations could be enforced by towing of vehicles, with the required signage posted at entrance; windshield stickers could be placed on non-compliant vehicles; Travis County Sheriff and Travis County Fire/ESD No 1, code compliance, contact for compliance. Council will continue to monitor these situations and address violations with Travis County Sheriff, Code Compliance and individuals in non-compliance.

- Discussion of amendments to Village of Point Venture Code of Ordinances, Chapter 3 Animal Control, concerning regulations for registration of dogs and amendments to Appendix A, section A2.001, concerning fees for registration of dogs. Council discussion with Animal Control Officer regarding update to Article 3.01.005 Registration of Dogs to one lifetime pet registration fee. Rabies vaccines continue to require current rabies vaccination documentation be provided. Council request draft ordinance for second review at January regular Council meeting.
- 4. Discussion of amendments to Village of Point Venture Code of Ordinances, Chapter 3 Animal Control, concerning regulations for restraining and tethering of dogs. Council discussion with Animal Control Officer regarding update to Article 3.03.007 Tethering of Dogs. Village code as written is not enforceable. Suggestion to update unattended restraint of dogs as imposed by Chapter 821, Subchapter E of the Texas Health and Safety Code and request additional regulations to apply to the restraint of dogs in the Village of Point Venture. Council request to review update to Article 3.03.007 to align with Texas State code, adding further regulations to delete tethering in front yards within the Village. Council also request to review update to Article 3.03.007 to only align with Texas State code and no further local regulations imposed for dog tethering. Council will review at the January regular Council meeting.

#### **ORDINANCE NO. 2025-01-15**

AN ORDINANCE OF THE VILLAGE OF POINT VENTURE, **TEXAS, AMENDING CHAPTER 3 OF THE VILLAGE OF POINT VENTURE CODE OF ORDINANCES; PROVIDING RULES AND REGULATIONS FOR THE REGISTRATION AND VACCINATION** OF DOGS: AMENDING THE VILLAGE OF POINT VENTURE PROVIDING FEE **SCHEDULE: FINDINGS** OF FACT: PROVIDING FOR REPEAL, SEVERABILITY, SAVINGS, PUBLICATION AND CODIFICATION; DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED IS **OPEN TO THE PUBLIC AS REOUIRED BY LAW: PROVIDING A** PENALTY: AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Village Council of the Village of Point Venture ("Village Council") seeks to provide for the public health, safety and welfare of its citizens; and

**WHEREAS**, pursuant to Section 51.001 of the Texas Local Government Code, the Village of Point Venture may adopt and amend ordinances for the good government, peace and order of the Village, as necessary or proper for carrying out a power granted by law to the Village; and

**WHEREAS**, pursuant to Section 826.031 of the Texas Health and Safety Code, the governing body of a municipality may adopt an ordinance requiring the registration of each dog within the jurisdiction of the municipality; and

**WHEREAS**, pursuant to Section 826.015 of the Texas Health and Safety Code, the governing body of a municipality may adopt an ordinance establishing a local rabies control program in the municipality and may set local standards regarding same; and

**WHEREAS**, the Village Council has previously adopted regulations governing animals, as codified in Chapter 3 of the Village of Point Venture Code of Ordinances; and

**WHEREAS**, the Village of Point Venture has previously adopted certain fees associated with the registration of dogs; and

**WHEREAS**, the Village Council of the Village of Point Venture desires to revise such fees to ensure the cost to the Village for providing the service associated with the fees bear a reasonable relationship to the established fees; and

WHEREAS, the Village Council of the Village of Point Venture finds that the fees, as

amended, bear a reasonable relation to the cost involved in the registration obligations; and

**WHEREAS**, the Village Council finds the amendment of dog registration and vaccination regulations is necessary for the good government, peace and order of the Village.

# NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF POINT VENTURE, TEXAS:

**SECTION 1. Findings of Fact.** All of the above recitals and premises are hereby found to be true and correct legislative and factual findings of the Village Council of the Village of Point Venture, Texas and are hereby approved and incorporated into the body of this Ordinance as if copied in their entirety.

**SECTION 2. Ordinance Amendment.** The Code of Ordinances of the Village of Point Venture, Texas is hereby amended by deleting Section 3.01.005 of Chapter 3 thereof and substituting therefor a new Section 3.01.005 of Chapter 3 as set forth in Exhibit A, attached hereto.

**SECTION 3. Fee Schedule Amendment.** Appendix A of the Code of Ordinances of the Village of Point Venture, Texas is hereby amended by deleting sections A2.001 thereof and substituting therefor new section A2.001 as set forth in Exhibit B, attached hereto.

**SECTION 4. Repeal.** All provisions of the ordinances of the Village of Point Venture in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict, and all other provisions of the ordinances of the Village of Point Venture not in conflict with the provisions of this Ordinance shall remain in full force and effect.

**SECTION 5. Severability.** Should any sentence, paragraph, subdivision, clause, phrase or section of this Ordinance be adjudged or held to be illegal, invalid or unconstitutional, the same shall not affect the validity of this Ordinance as a whole, or any part or provision thereof, other than the part so decided to be invalid, illegal or unconstitutional, and shall not affect the validity of any remaining provision of the Code of Ordinances or the Code of Ordinances as a whole.

**SECTION 6. Savings.** All rights and remedies of the Village of Point Venture are expressly saved as to any and all violations of the provisions of any ordinances which have accrued at the time of the effective date of this Ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances, shall not be affected by this Ordinance but may be prosecuted until final disposition by the courts.

**SECTION 7. Publication and Codification.** The Village Secretary of the Village of Point Venture is hereby directed to publish the Caption, Penalty and Effective Date of this Ordinance as required by Section 52.011 of the Texas Local Government Code. The Village Secretary is further directed to have this Ordinance codified at the next available codification update.

**SECTION 8. Open Meeting.** The Village Council of the Village of Point Venture hereby finds and determines that the meeting at which this Ordinance was adopted was open to the public and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.

**SECTION 9. Penalty.** It shall be unlawful for any person to violate any provision of this Ordinance, and any person violating or failing to comply with any provision hereof shall be fined, upon conviction, in an amount not more than Five Hundred Dollars (\$500.00), in accordance with the enforcement and penalty provisions, and a separate offense shall be deemed committed each day or part of a day during or on which a violation occurs or continues. Further, if the Village Council of the Village of Point Venture determines that a violation of this Ordinance creates a threat to the public safety, the Village may bring suit in the District Court to enjoin such violation and may exercise all available remedies as allowed by law.

**SECTION 10. Effective Date.** This Ordinance shall take effect immediately from and after its passage and publication as may be required by governing law.

#### **CHAPTER 3 ANIMAL CONTROL**

#### **ARTICLE 3.01 GENERAL PROVISIONS**

. . .

#### 3.01.005 Registration And Vaccination Of Dogs

- (a) <u>Registration of dogs</u>.
  - (1) <u>Registration requirement</u>. The owner of a dog or a person caring for or harboring a dog over the age of four (4) months which resides in the village for a period of thirty (30) days or more shall register such dog with the village.
  - (2) <u>Registration process and certificate</u>.
    - (A) Any person registering a dog shall submit an application, a photograph of such dog, and proof of current rabies vaccination and shall pay the registration fee as determined by the council.
    - (B) Upon submission of a complete application, the village shall issue a registration certificate to applicant. Such certificate shall be valid for the life of the dog, subject to the change of ownership requirements provided for in this chapter.
    - (C) Each registration certificate shall state the following:
      - (i) The name, address, and telephone number of the owner or care provider of the dog;
      - (ii) The name, address, and telephone number of an alternate person responsible for the dog (if requested by the applicant);
      - (iii) A description of the dog for which the registration is issued;
      - (iv) The name of the dog for which the registration is issued; and
      - (v) The number of the tag issued for the dog.
    - (D) The registrant shall be required to submit to the village an updated photograph if there is a significant change in the dog's appearance.
    - (E) The registrant shall be required to submit to the village updated proof of current rabies vaccination within thirty (30) days of expiration of prior rabies vaccination.

- (3) <u>Registration tag</u>.
  - (A) The village shall provide a registration tag to the applicant for each dog the village registers.
  - (B) The applicant shall ensure the dog has its registration tag affixed to the dog's collar at all times the dog is not located inside a dwelling.
  - (C) If the registration tag is lost or destroyed, the owner of, or the person caring for or harboring, the registered dog shall apply to the village for a new tag by presenting the dog's registration certificate and paying the fee as determined by the council.
- (4) <u>Change of ownership of dog</u>. Within thirty (30) days of any change in ownership of a registered dog under this section, the new owner shall transfer the dog's registration certificate to the new owner's name by submitting a registration application and paying the fee as determined by council.
- (5) <u>Control of visitors' dogs</u>. Nonresident workers, service personnel or visitors entering the village shall obtain permission from the owner or person in control of property before permitting a dog to enter upon such property. Such workers, personnel, or visitors shall ensure that their dogs have up-to-date rabies vaccinations and current rabies tags and shall keep their dogs physically restrained to the premises or under direct physical control when working, performing a service or visiting.
- (b) Rabies vaccination requirements.
  - (1) The owner of a dog or a person caring for or harboring a dog within the village limits shall have such dog vaccinated against rabies before the dog is four (4) months of age and revaccinated once every year for a one-year vaccine and once every three years for a three-year vaccine.
  - (2) The owner of, or person caring for or harboring, a dog of four (4) months of age or older within the village limits shall maintain a vaccination certificate issued by a veterinarian evidencing the status of the dog's rabies vaccination.
  - (3) The owner of, or person caring for or harboring, a dog of four (4) months of age or older residing within the village for a period of thirty (30) days or more shall ensure the dog has its vaccination tag affixed to the dog's collar at all times the dog is not located inside a dwelling.

**WHEREAS**, the Village Council of the Village of Point Venture ("Village Council") seeks to provide for the public health, safety and welfare of its citizens; and

**WHEREAS**, pursuant to Section 51.001 of the Texas Local Government Code, the Village of Point Venture may adopt and amend ordinances for the good government, peace and order of the Village, as necessary or proper for carrying out a power granted by law to the Village; and

**WHEREAS**, Chapter 821, Subchapter E of the Texas Health and Safety Code, provides regulations regarding the restraint of dogs; and

**WHEREAS**, pursuant to Section 821.104 of the Texas Health and Safety Code, the governing body of a municipality may adopt an ordinance relating to the restraint of a dog provided the requirement is compatible with and equal to or more stringent than the state law or relates to an issue not specifically addressed by state law; and

**WHEREAS**, the Village Council has previously adopted regulations governing animals, as codified in Chapter 3 of the Village of Point Venture Code of Ordinances; and

**WHEREAS**, the Village Council finds that the regulations contained within this ordinance are compatible with and equal to or more stringent than the state law and relate to an issue not specifically addressed by state law; and

**WHEREAS**, the Village Council finds the amendment of dog restraint regulations is necessary for the good government, peace and order of the Village.

# NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF POINT VENTURE, TEXAS:

SECTION 1. Findings of Fact. All of the above recitals and premises are hereby found to be

true and correct legislative and factual findings of the Village Council of the Village of Point Venture, Texas and are hereby approved and incorporated into the body of this Ordinance as if copied in their entirety.

**SECTION 2. Ordinance Amendment.** The Code of Ordinances of the Village of Point Venture, Texas is hereby amended by deleting Section 3.03.007 of Chapter 3 thereof and substituting therefor a new Section 3.03.007 of Chapter 3 as set forth in Exhibit A, attached hereto.
